TPS563300EVM-226 3-A Regulator Evaluation Module



ABSTRACT

This user's guide contains information for the TPS563300 as well as support documentation for the TPS563300 evaluation module. Included are the performance specifications, board layout, schematic, and the list of materials of the TPS563300EVM.

1 Introduction

The TPS563300 is a high efficiency, easy-to-use synchronous buck converter. With the wide input voltage range of 3.8 V to 28 V, the device is ideally suited for systems powered from 5-V, 12-V, 19-V, 24-V power-bus rails. The device supports up to 3-A continuous output current, 0.8-V to 22-V output voltage and maximum 98% duty cycle operation. The device employs fixed-frequency peak current control mode for fast transient response and good line and load regulation. The optimized internal loop compensation eliminates external compensation components over a wide range of output voltage and operation frequency. Pulse frequency modulation (PFM) mode maximizes the light load efficiency. The low quiescent current feature is beneficial for long battery life time in low-power operation. The device also has a frequency spread spectrum feature, which helps with lowering down EMI noise.

The TPS563300EVM evaluation module (EVM) is a single, synchronous buck converter providing 5 V at 3 A from 5.1-V to 28-V input. This user's guide describes the TPS563300EVM performance. Rated input voltage and output current ranges for the evaluation module are given in Table 1-1.

2 Performance Specification Summary

A summary of the TPS563300EVM performance specifications is provided in Table 2-1. Specifications are given for an input voltage of V_{IN} = 24 V and an output voltage of 5 V, unless otherwise noted. The ambient temperature is 25°C for all measurement, unless otherwise noted.

3 Modifications

These evaluation modules are designed to provide access to the features of the TPS563300. Some modifications can be made to this module.

3.1 Output Voltage Setpoint

To change the output voltage of the EVMs, change the value of resistor R_4 . Changing the value of R_4 can change the output voltage. Use Equation 1 to calculate the value of R_4 for a specific output voltage.

$$R_4 = \frac{R_5 \times (V_{out} - 0.8)}{0.8} \tag{1}$$

4 Test Setup and Results

This section describes how to properly connect, set up, and use the TPS563300EVM. The section also includes test results typical for the evaluation modules and efficiency, output load regulation, output line regulation, load transient response, output voltage ripple, input voltage ripple, start-up, and shutdown.

4.1 Input and Output Connections

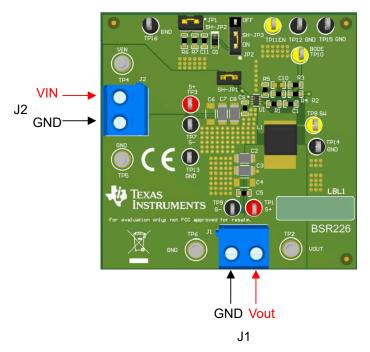


Figure 4-1. TPS563300EVM Connectors and Jumpers Placement

The TPS563300EVM is provided with input and output connectors and test points as shown in Table 4-1. Figure 4-1 shows connectors and jumpers placement on TPS563300EVM board.

A power supply capable of supplying 3 A must be connected to J2 through a pair of 20-AWG wires. The load must be connected to J1 through a pair of 20-AWG wires. The maximum load current capability is 3 A. Wire lengths must be minimized to reduce losses in the wires. Test point TP3 provides a place to monitor the V_{IN} input voltages with TP7 providing a convenient ground reference. TP1 is used to monitor the output voltage with TP9 as the ground reference.

4.2 Start-Up Procedure

- 1. Ensure that the jumper at JP2 (Enable control) pins 2 and 3 are covered to shunt EN to GND, disabling the output.
- 2. Apply appropriate V_{IN} voltage to VIN (J2-1) and GND (J2-2).
- 3. Move the jumper at JP2 (Enable control) pins 2 and 3 (EN and GND) to enable the output.

4.3 Load Transient Response

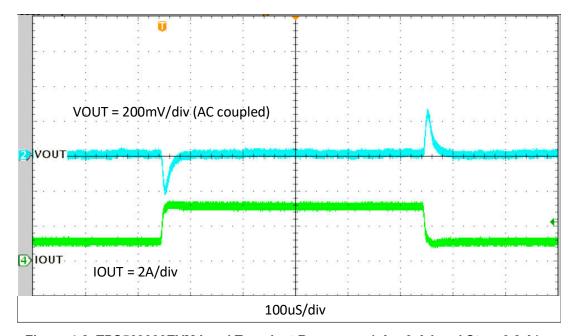


Figure 4-2. TPS563300EVM Load Transient Response, 1-A - 3-A Load Step, 0.8 A/µs

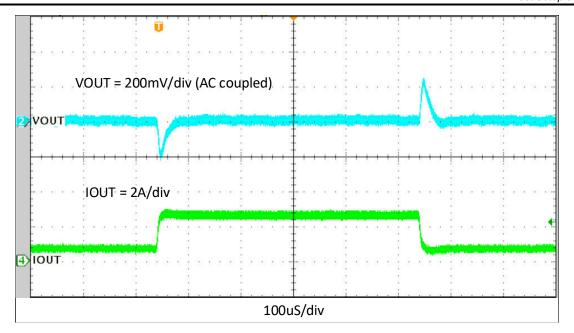


Figure 4-3. TPS563300EVM Load Transient Response, 0.5-A – 2.5-A Load Step, 0.8 A/μs

The TPS563300EVM response to load transient is shown in Figure 4-2 and Figure 4-3. The current steps and slew rates are indicated in the figures with 20-MHz scope bandwidth. Total peak-to-peak voltage variation is as shown.

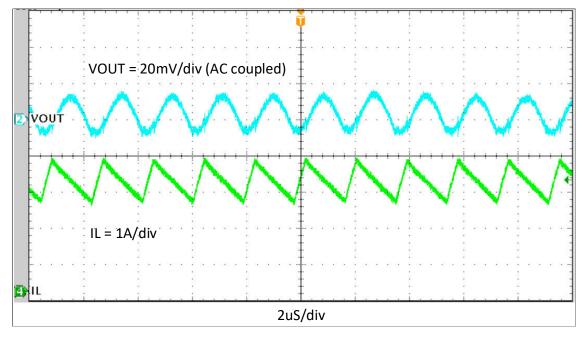


Figure 4-4. TPS563300EVM Output Voltage Ripple, I_{OUT} = 3 A

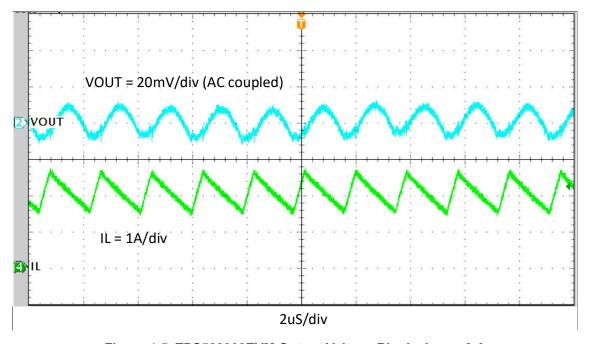


Figure 4-5. TPS563300EVM Output Voltage Ripple, I_{OUT} = 2 A



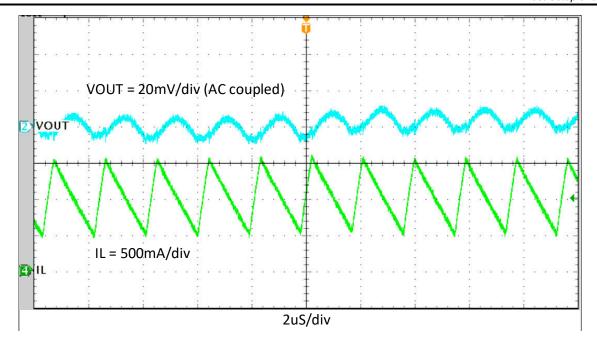


Figure 4-6. TPS563300EVM Output Voltage Ripple, $I_{OUT} = 1 A$

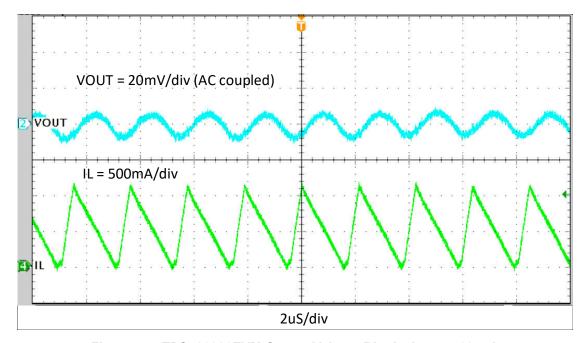


Figure 4-7. TPS563300EVM Output Voltage Ripple, I_{OUT} = 500 mA

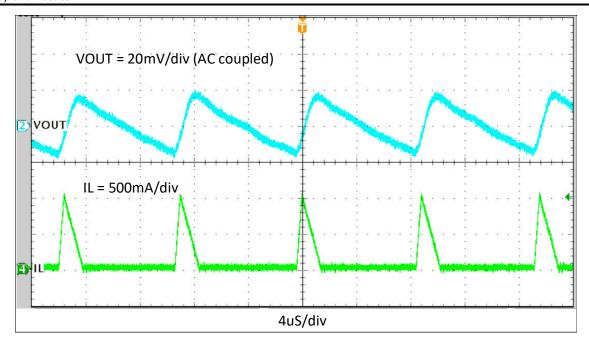


Figure 4-8. TPS563300EVM Output Voltage Ripple, I_{OUT} = 100 mA

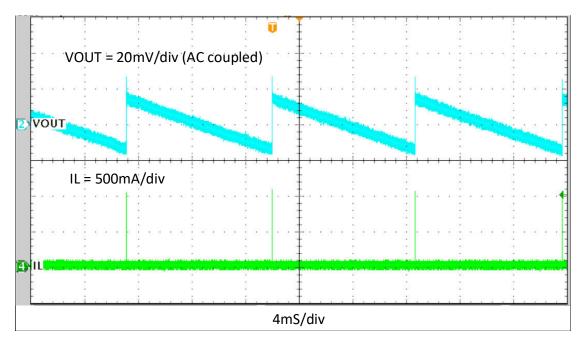


Figure 4-9. TPS563300EVM Output Voltage Ripple, I_{OUT} = 0 A

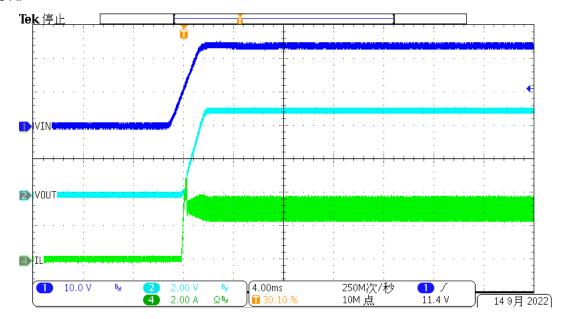


Figure 4-10. TPS563300EVM Start-Up Relative to V_{IN}

The TPS563300EVM start-up waveform with 20-MHz scope bandwidth relative to V_{IN} is shown in Figure 4-10. Load = 3 A.

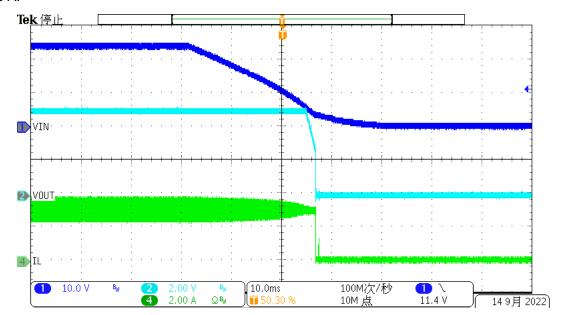


Figure 4-11. TPS563300EVM Shutdown Relative to V_{IN}

The TPS563300EVM shutdown waveform with 20-MHz scope bandwidth relative to V_{IN} is shown in Figure 4-11. Load = 3 A.

5 Board Layout

This section provides a description of the TPS563300EVM, board layout, and layer illustrations.

5.1 Layout

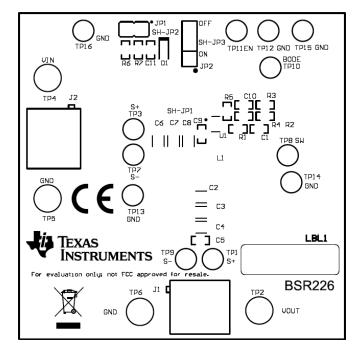


Figure 5-1. TPS563300EVM Top Assembly



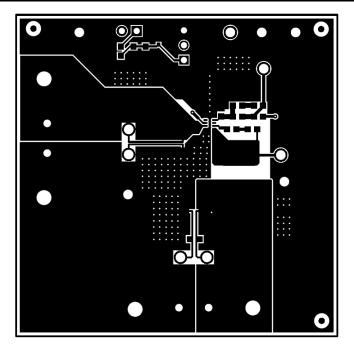


Figure 5-2. TPS563300EVM Top Layer

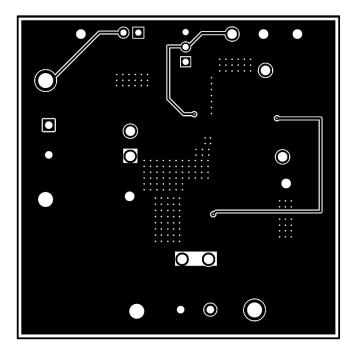


Figure 5-3. TPS563300EVM Bottom Layer

The board layout for the TPS563300EVM is shown in Figure 5-1, Figure 5-2, and Figure 5-3. The top layer contains the main power traces for VIN, VOUT, and ground. Also on the top layer are connections for the pins of the TPS563300 and a large area filled with ground. Most of the signal traces are also located on the top side. The input decoupling capacitors, C6, C7, C8, and C9 are located as close to the IC as possible. The input and output connectors, test points, and all of the components are located on the top side. The bottom layer is a ground plane along with the switching node copper fill, signal ground copper fill and the feed back trace from the point of regulation to the top of the resistor divider network. Both the top layer and bottom layer use 2 oz copper thickness.

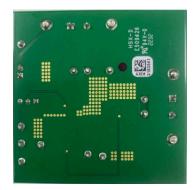


Figure 5-5. TPS563300EVM Board Bottom View

Figure 5-4 and Figure 5-5 are the TPS563300EVM board top view and bottom view, respectively.

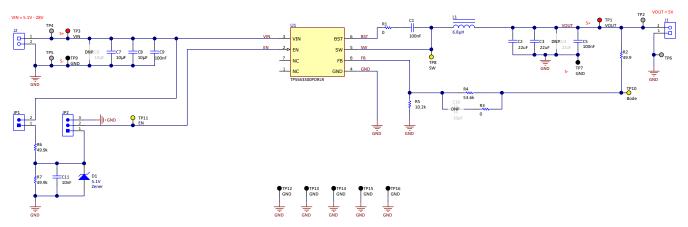


Figure 6-1. TPS563300EVM Schematic Diagram
