Description

ISOTMP35R is the industry-first reinforced isolated temperature sensor IC, and provides an analog output voltage proportional to Centigrade temperature. The ISOTMP35R has an analog output 10mV/°C positive slope gain along with a 500mV offset. The ISOTMP35REVM evaluation module is designed to evaluate the isolated temperature sensor. ISOTMP35REVM also features a detachable breakable ISOTMP35R temperature sensor board portion and a screw hole for easy attachment to a high-voltage bus bar or power MOSFET.



1 Evaluation Module Overview

1.1 Introduction

The ISOTMP35R evaluation module (EVM) uses a MSP430F5528 microcontroller along with a USB interface to enable the user to data log the temperature measurement results of the ISOTMP35R reinforced isolated analog temperature sensor. The EVM is comprised of two PCB sections, the microcontroller PCB section, and the sensor PCB section. The sensor PCB section can be separated or snapped off from the microcontroller if desired. In this case, the sensor side of the EVM must be reconnected to the microcontroller side to operate the ISOTMP35R in a high temperature or high voltage environment. The EVM also has a bottom-side copper plate that can be attached by thermal glue or screwed onto a high voltage heat source for easy user evaluation.

This users guide describes the characteristics, operation, and use of the ISOTMP35REVM for first customer samples release. A complete schematic diagram, printed-circuit board layouts, and bill of materials are included in this document.

1.2 Kit Contents

1.3 Specification

The controller side and the sensor breakout side of the EVM have different temperature limits, as shown in Table 1-2. The MSP430 limits the controller side temperature limits. The sensor breakout side temperature is limited by the ISOTMP35.

1.4 Device Information

ISOTMP35R is an isolated, linear analog output, temperature sensor designed to be connected directly to a high voltage heat source. The analog output is proportional to the ambient temperature, with a slope of +10mV/°C over the full sensor temperature range. A quick snapshot of key device specifications is shown in Table 1-3.

While the EVM is energized, never touch the EVM or the electrical circuits, as the electrical circuits can be at high voltages capable of causing electrical shock hazard.




Figure 2-1. ISOTMP35REVM Board Top Side




Figure 2-3. ISOTMP35REVM Board Block Diagram

2.2 High Voltage Connection Setup Guide

2.2.1 Detaching the Sensor

The ISOTMP35REVM functions with or without the sensor breakout board. However, to evaluate the ISOTMP35R in high voltage high temperature applications, the sensor breakout board must be detached to disconnect the breakout sensor board. To detach the sensor board and reconnect correctly, follow these recommendations:

- De-solder bridge connectors from pads on both side.
- Break off the sensor board from the controller board along the perforations.
- Reconnect sensor board and controller board with wires soldered to labeled pads. The signals traveling
 across these wires are low voltage, however the wires themselves must be rated to handle high-voltage
 levels.

Note

Depending on the application, the sensor board can be connected in such a way that the wires connecting the EVM cross over other high voltage signals or components. If low voltage rated wires are used in that case, then the wires and EVM can be damaged if the wires and EVM come into physical contact with a high voltage signal.

The user can also choose the voltage on the sensor breakout board 3.3V and GND pads. The ISOTMP35R can accept any supply voltage from 3V to 34V.

2.2.2 Attaching Sensor Section to High Voltage Heat Source

Once the user has reconnected the sensor breakout board, the user can attach the EVM to a high-voltage heat source using the bottom-side copper plate. This plate can be attached directly to a heat source, such as a heat-sink from a high-power MOSFET or a high-voltage bus bar, using glue or screws.

- For best thermal conductivity, do not place an insulator between the high-voltage heat source and the EVM bottom copper plate. Direct metal-to-metal contact is recommended.
- To decrease the ISOTMP35R response time, apply a thin layer of thermal conductive paste between the connector and the high-voltage heat source.
- Dissimilar metals in contact can increase the thermal resistance, to minimize this effect use thermal conductive paste.
- If screwing the EVM bottom copper connector on a high-power MOSFET, then TI recommends to minimize connection distance to the MOSFET.
- When screwing on the EVM to any high-voltage heat source, note that the FR4 expands and contracts with temperature. FR4 is a forgiving dielectric in terms of thermal expansion, but the user must periodically check that the screwing remains fastened when safe to do so.
- When gluing the EVM copper pad to a high voltage heat source, use as little glue as possible to make sure
 the connection is secure, excess glue increases the thermal resistance, therefore increasing response time.
 Once again, thermal conductive paste between the two different metals helps to reduce the metal-to-metal
 thermal resistance.

2.3 Perforations

There are perforations between the USB controller and the ISOTMP35R, these exist so that after the bridge connectors between the pads are desoldered, the two sides of the EVM can be broken apart easily.

2.4 Status LEDs and Subregulator

The ISOTMP35REVM includes LEDs to indicate the board status; the green LED D3 illuminates when voltage is supplied to the 3.3V net. The 3.3V net is connected directly to pin 1 of the ISOTMP35R. U1 is the onboard regulator which supplied the 3.3V net, and is enabled and disabled by switch S1. For normal operation of the EVM, S1 must be enabled. When S1 is disabled, the green LED D3 turns off.

The red LED D4 is the MSP430F5528 status LED. Table 2-1 shows what the different modes of operation mean.

Table 2-1. D4 LED Status

2.5 Programming Header

The ISOTMP35REVM comes pre-loaded with firmware necessary for correct operation. Header J2 is provided for Spy-Bi-Wire access to the MSP430F5528, but TI does not recommend that users access this header or reprogram the device.

2.6 Pushbutton Switch

Switch SW1 is used for entering USB BSL mode; this can be used for firmware updates. To enter BSL mode, connect the EVM to a PC USB port while holding down SW1.

2.7 RC Filter

On the sensor breakout board, R15 and C20 can be used for an optional RC circuit to filter the voltage output of the ISOTMP35R. R15 is already installed on the board, but is a 0Ω jumper so acts as a short. C20 is not installed by default. The user can desolder R15, solder on a different resistor in the place of R15, and solder on a capacitor for C20 to create an RC filter.

The user must be aware to not use a capacitor value greater than 120nF for C20. The ISOTMP35R has a maximum capacitive load of 220nF, however C17 on the controller portion of the EVM is a 100nF cap that is loaded onto the output voltage line. C17 prevents the voltage from dropping on the microcontroller ADC input, so C17 must not be removed. The ADC pin of the MSP430F5528 has 15pF of capacitive loading as well, although this is considered negligent when working on the scale of hundreds of nF.

To maintain output stability, phase margin (PM) must not be allowed to drop below 65° . When choosing a resistor and capacitor for an RC filter, take care to refer to the ISOTMP35R data sheet to find resistor and capacitor values to keep the PM above 65° . C17, the 100nF capacitor placed near the ADC on the MCU side of the PCB, does count as part of the total capacitance for the PM calculation. For example if the user wants a filter with 200nF and 950Ω , the user must install a 100nF capacitor for C20.

3 Software

The ISOTMP35REVM software allows a user to read temperature from the ISOTMP35 by using the MSP430F5528. The analog output voltage is read by the microcontroller and converted to displayed temperature in software. Once the EVM hardware is connected to the GUI, temperature is sampled automatically once the user navigates to the *Data Capture* tab. The ISOTMP35REVM GUI also contains a functional block diagram, key specifications, and associated collateral for ISOTMP35.

3.1 Software Download

The PC GUI Software for ISOTMP35REVM runs on TI's GUI Composer framework. The software is available as a live version that runs in a browser and as a download for offline use. The software is compatible with Microsoft® Windows®, Mac®, and Linux® operating systems.

3.1.1 Online Software

Access the online version by navigating to https://dev.ti.com/gallery/info/THSApps/ISOTMP35REVM. The online software works with Google Chrome[®], Firefox[®], and Safari[®] browsers. Users can access the live GUI be following the link and clicking on the application icon withing the gallery to launch the software. If prompted, install the TI Cloud Agent browser plug-in.

3.1.2 Offline Software

Fully offline version can be accessed by navigating to https://dev.ti.com/gallery/info/THSApps/ISOTMP35REVM and downloading the application and runtime for Linux, Mac, or Microsoft Windows, and then following the on-screen installation instructions.




Figure 3-1. Download Pop-Up

3.2 Home Tab

When opening the GUI, the Home tab is displayed, see the figure below. From the home tab, device features such as a key specs and a functional block diagram can be seen when clicking the Learn More button. From the Home tab, there are shortcuts on the left bar and on the bottom to the Data Capture tab and the Collateral tab.




Figure 3-2. Home Tab

3.3 Data Capture Tab

The Data Capture tab automatically begins making temperature measurements. The data displays on a graph that scales with the temperature readings with recorded temperature on the y-axis, and measurement count on the x-axis. The default capture rate is 1 measurement per second. The drop-down menu allows the user to choose a different measurement rate, with the following options:

- Off
- As fast as possible
- Every 500ms
- Every 1s
- Every 5s
- Every 10s
- Every 60s

The SAVE START and SAVE STOP buttons enable the user to log the EVM temperature results in a .csv file. When SAVE START is selected, the file begins downloading, and downloading ends when SAVE STOP is selected.




Figure 3-3. Data Capture Tab




Figure 3-4. Collateral Tab




Figure 4-1. ISOTMP35REVM Schematic




Figure 4-2. Top View




Figure 4-3. Bottom View
