Snubber Power Dissipation

$P = 1/2 * C * (Vp^2 - Vn^2) * Fsw$
 Where Vp and Vn are the positive and negative voltage spikes across the snubber resistor.


Use $Vp = Vn = Vin$ as initial approximation.
 $P = 330pF * 8.6V^2 * 300kHz = 7.32mW$

Peak Input Current

Current limit = $0.075V / 0.003ohm = 25A$
 Inrush limit = $0.110V / 0.003ohm = 36.7A$
 Circuit breaker = $0.160V / 0.003ohm = 53.3A$

Inrush Limiting

$T = 333uF * 8.6V / 36.7A = 78us$
